2. COMPETITION SPECIFIC

Preliminary Inquiry & Technical Meeting (if any)

Mandatory attendance is required for **both players** of the team for the Preliminary Inquiry & Technical Meeting (if any).

The access to the location of Preliminary Inquiry will be controlled to avoid mass gathering.

Players are required to attend the Preliminary Inquiry and present their passports, accessories to the Technical Delegate. Failure to provide these documents will entail a disqualification of the team concerned.

All players wishing to take part to a VW Beach Pro Tour Futures Event must fully comply with the requirements set by the CEV/FIVB regulatory framework.

These includes, but not limited to:

- Completed and signed the 2024 Beach Volleyball Player Participation Agreement and BVB-10 Annual Health Certificate documents to be duly uploaded to the VIS
- have completed the <u>FIVB anti-doping Education and Certification program</u>
- have undertaken the FIVB E-learning Course on the Prevention of Competition Manipulation course

Provisional Match schedule

The detailed match schedule will be published immediately on the Volleyball World & CEV websites once approved by the Technical Delegate onsite. It will be no later than 1 hour after the end of last match of day or 1 hour after the seeding list is established after Preliminary Inquiry.

Country Quota Playoff – Optional only if applicable:

It is highly recommended to avoid any Country Quota Playoff onsite, due to the uncertainty of the availability of courts at the venue and also for the cost saving for teams to travel along the way and play this Playoff. However, NFs willing to organise Country Quota Playoff matches onsite should contact organisers directly within a week after the issuing of the Confirmed lists to explore such a possibility.

While the FIVB and CEV will attempt to facilitate the cooperation between the National Federations and tournament organisers, financial conditions must be offered through a rate card service by the tournament organisers.

Should the Country Quota Playoff matches be held on-site, matches should be organised on the same day of the Referee Clinic and before the Preliminary Inquiry of Qualification Tournament with a maximum of three (3) matches per gender for each National Federation and in single elimination format.

World Ranking Points

The awarding of the FIVB World Ranking points will be applied for this event as per the FIVB Beach Volleyball Sport Operations Manual, in case a fair access to all eligible and registered to participate athletes is ensured and will be confirmed after the issuing of the confirmed lists.

Uniform and Accessories:

The playing tops/tanks will be provided by the organiser for all Main Draw and Qualification players as per the breakdown shared by the CEV.

. Shorts/bottoms and accessories must be provided by the players and/or by their sponsors.

If required by the Technical Delegate, other uniforms and accessories will be checked during the Preliminary Inquiry.

Athletes of the same team must wear uniform of same colour.

The uniforms guidelines including the display of the individual players' sponsors' logos on shorts and accessories must comply with the FIVB Beach Volleyball Sport Operations Manual.
