1. Event Information

1.1. Date and Venue

The CEV Beach Volley European Cup will be hosted in Balıkesir, Türkiye, from 5 to 8 October 2023 for both men and women. The exact competition dates per gender will be announced following the end of the Clubs registration deadline.

1.2. Number of Participating Clubs

The 2023 edition of the CEV Beach Volley European Cup will be a standalone event with the participation of minimum 8 and maximum 12 clubs per gender.

The final figure will be announced following the end of the Clubs registration deadline.

1.3. Registration of Clubs

NFs with a Homologated National BV Clubs competition may register a maximum of 2 Clubs through the *CEV Beach Volley European Cup Registration Application Form*.

The form needs to be submitted to the CEV by mail no later than the **10th of September 2023**.

1.4. Registration of Athletes

Each Club registered through their National Federation needs to upload to the CEV cloud https://cloud.cev.eu/url/BV_Clubs_competition under their respective NF folder and no later than **15th September 2023**, the following documents:

- The *2023 CEV BV European Cup Registration of Athletes Form* indicating the athletes that may represent the Club to the competition.
The form allows the registration of up to 10 athletes in total, out of whom the Club will need to present the minimum of 4 and the maximum of 6 athletes that will attend the event Preliminary Inquiry.
- The *2023 CEV Beach Volley European Cup Commitment Form* (three-part agreement between the NF / Club and Athlete) for each of the inscribed athletes, which confirms the mutual agreement of Club and athlete to participate in the competition, with the approval of the respective NF.
- In case an athlete has a different NF of Origin from the NF to which the Club is registered, the Club also uploads the *letter of Support from the National Federation of Origin form* of the concerned athlete for its participation in the CEV Competition.

1.5. Competition Format

The competition will be played in a Club vs Club, double header format in 2 phases:

- a preliminary pool play phase in Round Robin format where each Club plays each other in 2 matches, with each match allocating 2 points to the winning and 1 point to the losing Club.
- a single elimination final phase where each Club plays each other in 2 matches. In case of a tie after two matches the 3rd and deciding match will be played as a Golden Set.

Each Club will be confirming the composition and order of play of their 2 teams and the potential substitutes for each match the latest 60 minutes before each double header through the Coach/Head of Delegation.

Following the Clubs registration deadline, the CEV will conduct a Drawing of Lots to seed the participating clubs in the competition bracket according to the CEV Country Ranking as of 31st of August 2023.

Further details about the competition parameters will be detailed in the event's Practical Info.

1.6. Right of Participation

Athletes wishing to take part in the CEV Beach Volley European Cup must fully comply with the requirements set in the CEV Beach Volley European Cup Official Communication No1 and No2.

1.7. Accreditation request

The accreditation of team officials will be detailed in the Event's Practical Info document.

1.8. Prize money

Prize Money of 10,000 EUR per gender will be allocated to the top-three Clubs in the final standing of the competition as per the following breakdown and the provisions of the CEV Beach Volleyball Competition Regulations:

Rank	Prize money (per Club)
1	5,000 €
2	3,000 €
3	2,000 €

1.9. Rules of the Game

As per the information announced in the CEV Beach Volley European Cup Official Communications No1 and No2, and with the announced exceptions that will be further detailed in the events Practical Info.

1.10. Athletes' Uniforms & Accessories

Each Club is responsible for providing all delegations members with uniforms, including the athletes' tops/jerseys as per the layouts annexed to the CEV Beach Volley European Cup Official Communication No2 and may use their sponsors in the indicated positions.

The uniforms need to be presented for approval during the Preliminary Inquiry. In case of non-conformity, sanctions may apply as per the CEV Beach Volleyball Regulations.

1.11. Transportation & Accommodation

As announced in the CEV Beach Volley European Cup Official Communication No1, participating Clubs are responsible for their International Travel and accommodation expenses.

The Organiser will be offering board & lodging options for the participants that will be detailed in the Event's Practical Info.

1.12. Ranking Points

No world ranking points are allocated to the participating athletes. From 2024, the CEV will introduce a specific NF ranking based on the results and final classification of Beach Volley Clubs involved in the competition.

2. Financial Regulations

2.1. Participation & License Fee

A participation and License fee will be applied to all participating Clubs as per the information announced in the CEV Beach Volley European Cup Official Communication No1.

3. Further Information

All necessary competition specific information will be circulated to the participating Clubs through the event's Practical Info document.

1. Introduction

Following the circulation of the CEV Beach Volley European Cup Official Communication No1, the CEV is herein providing additional and updated information over the introduction of this new initiative and its addition to the European Beach Volleyball ecosystem.

2. Qualification process

The Qualification process is run by each National Federation (NF from here onwards) in their territory and needs to be communicated to the CEV with the respective National Beach Volley Clubs competition Homologation Form that is available on the CEV website.

The CEV strongly recommends to all NFs to apply the same competition format that will be used for the CEV Beach Volley European Cup where Beach Volleyball Clubs compete in a double header format (meaning that two teams from each club face the other's).

The CEV has decided to postpone the initially communicated deadline for submitting the respective form to **15 of May 2023**, allowing enough time for NFs to plan their activities.

Each homologated National Beach Volley Clubs competition will automatically grant a place in the Beach Volley European Cup.

As per the timeline communicated in the CEV Beach Volley European Cup Official Communication No1, the qualification process needs to be concluded by **August 31, 2023, at the very latest**.

3. Competition Parameters

3.1. Registration

NFs with a Homologated National BV Clubs competition will receive together with their homologation an access code to the CEV Cloud. The qualified Clubs need to be registered by their NF **by September 1st, 2023** through the [CEV Beach Volley European Cup Registration Application Form](#).

Each registered to the Beach Volley European Cup Club needs to upload to the CEV cloud the following:

- A [Registration of Athletes Form](#) indicating the athletes that will represent the Club to the competition by September 15, 2023, at the latest.
- The [2023 CEV Beach Volley European Cup Commitment Form](#) (three-part agreement between the NF / Club and Athlete) for each of the inscribed athlete, which confirms the mutual agreement of Club and athlete to participate in the competition, with the approval of the NF by September 15, 2023, at the latest.
- In case an athlete has a different NF of Origin from the NF to which the Club is registered, the Club also uploads [the letter of Support from the National Federation of Origin form](#) of the concerned athlete for its participation to the CEV Competition.

3.2. Right of Participation

Athletes wishing to take part in the CEV Beach Volley European Cup must fully comply with the following requirements:

- Be duly registered in the Volleyball Information System (VIS) and meet the FIVB/CEV eligibility criteria
- Have a valid FIVB or CEV Health Certificate
- Have completed both the FIVB "Play Clean" anti-doping course as well as the FIVB e-learning course on the Prevention of Competition Manipulation

Only athletes not suspended by CEV and/or FIVB are allowed to participate in the competition.

3.3. Competition format

The 2023 edition of the CEV Beach Volley European Cup will be a standalone event whose delivery is planned for the period October/November 2023 with the participation of 8 clubs per gender.

The above figure can be increased to 12 due to competition and promotional criteria.

The competition will be played in a Club vs Club double header format in 2 phases:

- a preliminary pool play phase
- a single elimination final phase

Each Beach Volleyball Club participates with a delegation of minimum 4 and maximum 6 athletes, plus minimum 1 coach and one Head of Delegation.

Men's and Women's competitions will run separately from each other.

Following the registration deadline, the CEV will conduct a Drawing of Lots to seed the teams in the competition bracket according to the CEV Country Ranking as of 31st of August 2023. The seeding details will be detailed in the event's Practical Info

3.4. Event Dates

The event conditions to host the CEV Beach Volley European Cup are detailed in the Candidature Application Guidelines that can be found in the following link: <https://inside.cev.eu/event-bidding/events/>

Any National Federation registering Clubs to the competition has the right to apply for the organisation of the event.

The exact event dates and the organiser will be communicated following the end of the candidature application process which is set for August 31, 2023.

3.5. Prize money

Prize Money of 10,000 EUR per gender will be allocated to the top-three ranked Clubs as per the following breakdown and the provisions of the CEV Beach Volleyball Competition Regulations:

Rank	Prize money (per Club)
1	5,000 €
2	3,000 €
3	2,000 €

3.6. Rules of the Game

As per the information announced in the CEV Beach Volley European Cup Official Communication No1, and with the announced exceptions that will be further detailed in the events Practical Info.

3.7. Athletes' Uniforms & Accessories

Each participating Club is responsible for providing all delegations members with uniforms, including the athletes' tops/jerseys as per the layouts annexed to this Official Communication, and may use their sponsors in the indicated positions.

The uniforms need to be presented for approval during the Preliminary Inquiry. In case of non-conformity, sanctions may apply as per the CEV Beach Volleyball Regulations.

3.8. Transportation & Accommodation

As announced in the CEV Beach Volley European Cup Official Communication No1, participating Clubs are responsible for their International Travel and accommodation expenses.

The Organiser will be requested to offer board & lodging options for the participants.

3.9. Ranking Points

No world ranking points are allocated to the participating athletes.

From 2024 the CEV will introduce a specific NF ranking based on the results and final classification of Beach Volley Clubs in the competition.

4. Financial Regulations

4.1. Participation & License Fees

A participation and License fee will be applied to all participating Clubs as per the information announced in the CEV Beach Volley European Cup Official Communication No1.

5. Further Information

All necessary competition specific information will be circulated to the participating Clubs through the event's Practical Info document and following the appointment of the Organiser.

1. Introduction

The **CEV Beach Volley European Cup** is a newly introduced CEV initiative, which aims to expand the existing portfolio of Beach Volleyball events by adding Beach Volleyball Clubs to the European Beach Volleyball ecosystem and growing the sport by establishing additional partnerships and synergies through a new competition scheme.

With this product, the CEV wishes to support the establishment and development of Beach Volleyball club competitions both at the national level as well as on the international stage, doing so in close collaboration with the respective National Federations.

Qualification to the CEV Beach Volleyball Clubs competition will be linked to the delivery of National competitions homologated by the CEV, as per the timelines detailed in Article 2 of this document. For the 2023 edition, the qualification can consist of multiple or standalone events.

Men's and Women's competitions will run separately from each other.

2. Timelines

Each National Federation with an already existing or planned National Clubs competition scheme is due to define and communicate to the CEV the respective information and the competition process in their territory (number of clubs, single event, multiple rounds, etc.) by **March 31, 2023**.

The qualification process needs to be concluded by **August 31, 2023, at the latest**.

Any qualified clubs need to be registered by the respective National Federation via the CEV database by **September 1, 2023**, while the registration of the participating athletes is due by **September 15, 2023**.

3. 2023 Competition Parameters

3.1. Competition format

The 2023 edition of the Beach Volley Clubs Competition will be a standalone event whose delivery is planned for the autumn of 2023, following completion of the national qualification and registration process as detailed in this document.

The competition is played in a Club vs Club format where each Beach Volleyball Club participates with 2 teams and a delegation of minimum 4 and maximum 6 athletes, plus minimum 1 coach and a Head of Delegation. Men's and Women's competitions run separately from each other.

The exact dates and format will be communicated at a later stage taking into consideration the number of homologated National events.

The organiser of the Final will be confirmed through a Candidature Application Process and announced at a later stage.

Each of the National Federations registering Clubs to the competition has the right to apply for the organisation of the event. Should more than one National Federation apply for the organisation or should no National Federation apply, the organiser will be drawn by the CEV.

Following the registration deadline, the CEV will conduct a Drawing of Lots. Participating Clubs will be drawn into pools considering their country ranking as of **August 31, 2023**.

3.2. Right of Participation

Any athletes wishing to take part in the CEV Beach Volley Clubs competition must fully comply with the following requirements:

- Confirm in writing their commitment to representing the respective Club, document to be provided by CEV to registered National Federations and Clubs
- Be duly registered in the Volleyball Information System (VIS) and meet the FIVB/CEV eligibility criteria
- Provide a letter of support from the National Federation of origin in case the athlete is registered by a different National Federation to the one the Club is representing, document to be provided by CEV to registered National Federations and Clubs
- Submit the Players' Commitment & Health Certificate form as per the CEV instructions
- Have completed both the FIVB "Play Clean" anti-doping course as well as the FIVB e-learning course on the Prevention of Competition Manipulation

Only athletes not suspended by CEV and/or FIVB are allowed to participate in the competition.

Each athlete may represent only one (1) Club per season.

3.3. Prize money

A Prize Money of 10,000 EUR will be allocated per gender, breakdown to be provided in a subsequent Official Communication.

3.4. Rules of the Game

All matches shall be played according to the FIVB Official Beach Volleyball rules in their latest edition.

Exception 1: The presence of a coach inside the field of play is allowed provided that this coach is duly accredited as per the relevant provisions and timeline.

The obligations and rights of coaches entering the field of play as well as their uniform layout are detailed in the CEV Coaching Regulations document.

Exception 2: Each Club retains the opportunity for 1 substitution during each match for medical or tactical reasons.

3.5. Athletes' Uniforms & Accessories

Each participating Club is responsible for providing all delegations members with uniforms, including the athletes' tops/jerseys as per the layouts defined by the CEV in a subsequent Official Communication.

Marketing exploitation of the uniforms remains with the Club and any rules to this extent will be detailed in a subsequent Official Communication as well.

3.6. Transportation & Accommodation

All participating Clubs are responsible for their International Travel and accommodation expenses.

4. Financial Regulations

4.1. Participation Fee

To participate in the CEV Beach Volley Clubs Competition, the respective Club shall pay a participation fee of 200,- EUR to the CEV through their respective National Federation.

4.2. License Fee

For each athlete participating in the CEV Beach Volley Clubs Competition, the respective Club shall pay upon receipt of the respective CEV invoice a license fee, as defined in the CEV Beach Volleyball Competition Regulations.

5. Further Information

All necessary information about the competition will be circulated to National Federations by using the Official Communications and the event's Practical Info documents.

Additional information concerning the competition and the registered teams will be published on the CEV Beach Volley Clubs competition section of the CEV website.
